Wireless Plan Specifications: Unlimited two way transactions only apply to ATM usage with an approved processor. If at any time ATMTrader determines that service is used for other purposes, or if usage is excessive, additional charges will apply and service may be terminated at ATMTrader's sole discretion

Customer represents and warrants that it has the right and power to enter into this Agreement and agrees to purchase or rent the equipment and subscribe to the wireless plan per the above specifications and with the following terms and conditions.

LIFETIME WARRANTY: ATMTrader warrants the XCELLERATE and ATMTRADER Wireless Gateway (Gateway) units as long as monthly payments are made by Customer and wireless service is provided by ATMTrader. Prior to submitting a warranty claim, please call our technical support team at 909-670-1988. If it is determined that the unit needs to be replaced, ATMTrader at its sole discretion will replace said Gateway with either a new or a refurbished unit. The malfunctioning unit must be returned to ATMTrader within 10 days accompanied by the FREE return shipping label issued by ATMTrader, otherwise the purchase price of said equipment will be charged. This warranty will automatically be null and void upon termination of Service or non-payment of monthly service charge. This warranty does not cover misuse or abuse, negligence of Customer, vandalism, theft or damage including fire, water damage, and damage attributable to electric power fluctuations or acts of God. Exclusions also include the failure to operate the Equipment in accordance with the manufacturer's environmental and other specifications.

PAYMENT: The first month's wireless plan rate plus shipping and handling and equipment cost (if purchased) are due prior to shipping equipment to Customer, all such charges will be deducted from bank account indicated herein via ACH (Automated Clearing House) or recurring card payment. Beginning with the second month of service, the monthly Wireless Charge will be ACH'd or charged from customer's account and will be assessed before the 5th calendar day of each month for the current month's service. Customer shall provide ATMTrader with written notice of any changes to any account for ACH purposes prior to the subsequent monthly charge. In the event that any charge is returned unpaid to ATMTrader or if payment is considered late, customer agrees to pay a \$25.00 fee per returned item.

TERM: The term of this agreement shall be for 24 months commencing on the date hereof. This Agreement will automatically renew on a monthly basis after the initial term. Either party may terminate this agreement by providing thirty (30) day prior written notice after completion of the initial 24-month term.

RETURNS/TERMINATION: In the event that this Agreement is terminated prior to the end of the initial term, Customer agrees to pay ATMTrader a fee equivalent to the number of months remaining in the initial term multiplied by the monthly Wireless Service Charge. In addition, if equipment is rented, such equipment must be returned to ATMTrader in good working condition upon termination. If equipment is not returned, the purchase price of such equipment will be charged and such fee will be deducted via ACH.

LIABILITY: ATMTrader's sole liability to Customer is limited to the price paid for the equipment as per this Agreement. ATMTrader shall not be liable for any losses, expenses or costs incurred by Customer or others due to breakdown or malfunction of equipment, nor is it liable for the loss of any ATM transactions or ATM revenue. In any dispute between the parties, the prevailing party shall be entitled to recover from the other party all reasonable costs including, without limitation, attorney's fees. This Agreement shall be interpreted and enforced in accordance with the laws of the State of California. The jurisdiction and venue for any legal proceeding to interpret or enforce this Agreement shall be in Los Angeles County, California. ATMTrader has the right to assign all or any part of its rights or obligations under this Agreement at any time to any entity it chooses. Customer shall not assign or in any way dispose of all or any part of its rights or obligations under this Agreement without prior written consent of ATMTrader or its successors or assigns. Notices required by the terms of this Agreement shall be sent in writing by registered or certified mail, addressed to the ATMTrader and the undersigned Customer have entered into this Agreement as of the date stated below.

PERSONAL GUARANTEE: The undersigned ("Guarantor") does hereby personally guarantee all representation, warranties, and obligations, sums due and owing hereunder to ATMTrader under this Agreement. This guarantee shall be effective as to the initial term and to the renewal of any term of this Agreement and any claims guaranteed hereby or extensions of time of payment. In the event Customer fails to perform in any manner with regard to this Agreement, the Guarantor do hereby promise to make all payments to ATMTrader in the same manner as if they were the principals of this Agreement. The undersigned hereby agrees to pay all sums due and all losses or expenses which may be incurred in collecting any indebtedness of Customer guaranteed hereunder or in enforcing this Personal Guarantee including but not limited to, attorney's fees. Guarantor authorizes ATMTrader to obtain consumer credit report to evaluate credit for purposes of this application. ATMTrader shall be under no obligation to give the undersigned notice of renewal or extension of existing obligations. This Guarantee shall be binding on Guarantor and shall inure to the benefit of ATMTrader and its successors and assigns.

ACH AUTHORIZATION RELEASE: The undersigned hereby authorizes ATMTrader to initiate debit entries for the fees pursuant to this executed Wireless Service Agreement. Customer agrees to keep the account funded to the extent needed to support such transactions. This authorization shall remain in effect unless cancelled by Company by providing written notice of cancellation as required by this Agreement. The undersigned represents and warrants to ATMTrader that the person executing this ACH Debit Authorization is an authorized signatory on the account referenced herein and all information regarding the account and the account holder is true and correct. In the event an ACH payment is returned unpaid, Customer agrees to immediately pay ATMTrader a returned ACH fee of \$30.00 per occurrence.
